


We opened a new exhibition of groundbreaking research by Vassar Professor H. Daniel Peck on Cole's beautiful paintings of Catskill Creek and hosted canoe trips on that very same body of water that runs through our local Village. We debuted monumental new artwork by the contemporary artist Shi Guorui in a new exhibition entitled, *Ab/Sense-Pre/Sense*, that was inspired by Cole and was celebrated in *The New York Times*.

We partnered with many, many fantastic partners to open the Hudson River Skywalk, a new scenic walkway connecting the homes and studios of Thomas Cole and his student Frederic Church over the Hudson River via The Rip Van Winkle Bridge.

We hosted the first annual Scholars' Dinner at The Century Association in New York City to underwrite our Cole Fellowship program, launching the next generations of museum leaders. At the annual Summer Party here in Catskill, this community brought us over the finish line of a five-year \$1.2MM campaign to establish a Program Endowment to support educational programming here in perpetuity.






THOMAS COLE NATIONAL HISTORIC SITE

The Thomas Cole National Historic Site is a National Historic Landmark presenting the original home and studios of the artist and early environmentalist Thomas Cole (1801-1848). Cole founded the first major art movement of the United States, now known as the Hudson River School of landscape painting. The nationally recognized museum is an affiliate of the National Park Service and operates as a forward-thinking nonprofit organization embracing change and continually pursuing authenticity and resonance. Thomas Cole's profound influence on America's cultural landscape inspires us to engage broad audiences through innovative educational programs that are relevant today. Our programming and operations are continually evolving under our initiatives for Greening and Diversity, Equity and Access.









ART HISTORY

This year, *The New Yorker* declared "There's a Cole revival underway" and hailed our nineteenth century exhibition in the New Studio as "sublime." The exhibition, *Thomas Cole's Refrain: The Paintings of Catskill Creek*, marked the first time that Cole's paintings of Catskill Creek, created from 1827 through 1845, were considered as an integral series. The exhibition was based on new scholarship researched by H. Daniel Peck, the exhibition's

curator and the John Guy
Vassar, Jr., Professor Emeritus
of English at Vassar College. The
exhibition was accompanied by a
book of the same title, published
by Three Hills, an imprint
of Cornell University Press.
Professor Peck observed how
"the paintings contain mysteries
- enigmatic figures, evocative
human structures, and symbolic
landforms - that tell stories
of their own." Professor Peck
presented the annual Curator's
Talk and gave us a behind-the-

scenes look into the exhibition.
We hosted the talk downtown
in the Village of Catskill at the
Lumberyard Center for Film and
Performing Arts.

In the Main House, we presented a new collection-based exhibition entitled *The Art of Emily Cole* that opened during Women's History Month in March. Emily Cole (1843-1913) was a professional artist and the daughter of Thomas Cole. Our new exhibition, *The Art of Emily Cole*, was the first

solo exhibition of her artwork on paper and porcelain, revealing her exquisitely painted botanicals. A nineteenth-century newspaper review of an exhibition of Emily's porcelain calls her work "unrivaled" for its "delicacy, purity of color, and transparency" The exhibition was curated by Amanda Malmstrom, 2019 Cole Fellow, in conversation with Kate Menconeri, Cole Site Curator and Director of Exhibition

and Collections, with research conducted by Rowanne Dean, 2018 Cole Fellow. Amanda also developed a special guided tour that was offered throughout the 2019 season, sharing the stories of five women who lived at the Thomas Cole Site in the nineteenth and twentieth centuries.

We hosted our 16th annual Sunday Salon series, bringing new scholarship and ideas to Catskill, New York. The conversation leaders were Sylvia Yount, Lawrence A.
Fleischman Curator in Charge
of the American Wing, The
Metropolitan Museum of Art;
Alan C. Braddock, Ralph H.
Wark Associate Professor
of Art History & American
Studies, College of William &
Mary, Co-curator of Nature's
Nation: American Art and
Environment at Princeton
University; and Jeanne Haffner,
Associate Curator of Hudson
Rising exhibition at the New
York Historical Society.





CONTEMPORARY ART

Our fourth annual exhibition in the series *OPEN HOUSE*: Contemporary Art in Conversation with Cole featured new work by the internationally acclaimed artist Shi Guorui. Originally based in Beijing, China, Shi Guouri now has a home and studio in Catskill, NY. The exhibition, SHI GUORUI: *Ab/Sense-Pre/Sense*, debuted a series of large-8 scale landscape photographs

inspired by Thomas Cole and installed throughout the historic Main House where Cole lived and worked.

The New York Times observed that the photographs are "like staring into the soul of the Catskills." Shi Guorui visited the places in nature that Cole painted and captured those magnificent landscapes today using the ancient camera obscura process.

Transforming box trucks and twenty-five-foot tents into cameras, Shi Guorui created giant photographic prints of iconic views, including Kaaterskill Falls.

For the exhibition, Shi Guorui converted a secondfloor room in the historic house into a walk-in camera obscura. Cole used that same room as a studio before moving his painting operation to the "Old Studio' in 1839.







The Hudson River Skywalk opened this year, creating a new scenic walkway at the place where the Hudson River School of landscape painting began. The six-mile out and back scenic walkway connects two National Historic Landmarks, the homes and studios of the American artists, Thomas Cole and his student Frederic Church, over the Hudson River via the Rip Van Winkle Bridge. The walkway offers sweeping views of the Hudson Valley and the

Catskill Mountains. The project also reconnects Cole's historic home and property to the Hudson River waterfront for the first time in over a century.

The Skywalk is a partnership with Olana, the NY State
Bridge Authority, and many other partners, and the grand opening ceremony on June 1 was a celebration of our joining together two towns and a village, and two great historic sites. The festivities began with a "parade of paintings"

originating from each historic site led by none other than Thomas Cole and Frederic Church. The groups met over the Bridge and celebrated a ribbon cutting hosted by the New York State Bridge Authority state dignitaries with a musical performance by students from Catskill High School.

To further expand our outdoor programming and connect with diverse audiences beyond traditional museum spaces, we hosted a series of canoe trips on Catskill Creek that launched from a local public park, Mawignack Preserve.

The program was developed in conjunction with the special exhibition of Cole's paintings of Catskill Creek. We partnered with Jeff Vincent, a Catskill Native, licensed guide, and founder of Catskill Mountain Wild. Participants paddled down the Creek, read Cole's writing about this very place, and stopped to sketch along the trip.











EDUCATION

The Thomas Cole Site presents annual free school programming that responds to expressed teacher needs for engaging material to teach the curriculum. Our programming uses American art to teach American history, such as Industrialization and Empire. We served 545 students this year with educational programming led by Thomas Cole Museum Educators both at the historic

site in Catskill, New York, and in regional classrooms. We served groups ranging from Catskill Elementary Public School students to Winterthur American Material Culture graduate students. Additionally, our teacher resources website page at theomascole.org/teacherresources offers free lesson plans and creative activities for teachers to use in their own classrooms.

This year, we graduated the tenth annual class of Cole Fellows. Congratulations to Peter Fedoryk, Katherine Pratt-Thompson, Amanda Malmstrom, and Maeve McCool!

The Cole Fellowship program addresses an urgent need to steward talented young people into the field of American art by giving them significant responsibilities and by showing them their work can be both rewarding and rewarded. The program welcomes recent college graduates to live and work at the historic site for a full year and complete a significant research project that is put to action to advance museum initiatives. The Fellows are encouraged to explore topics that are of particular interest to them.

The 2019-2020 Class of Cole Fellows are Anne Comer,

Hampton Des Smith, Marissa Hamm, and Alex McCarty. Anne is researching digital education games. Her project will build on the Thomas Cole Site's education initiative using American art to teach American history in school classrooms. Hampton is researching the portrayal of Native Americans in Thomas Cole's paintings. His project will expand the conversation about American

art at the Thomas Cole Site.

Marissa is researching life at
Cedar Grove in the first 125
years after Cole's death in
1848. Her project will inform
future on-site interpretation
of Thomas Cole's legacy.
Alex is researching Thomas
Cole's legacy as a protoenvironmentalist. His project
will inform the reinterpretation
of the second floor of the Main
House.







DEVELOPMENT AND GROWTH

In 2019 we successfully completed a five-year \$1.2MM campaign to establish a new Program Endowment to support educational programming at the Thomas Cole National Historic Site in perpetuity. The campaign was supported by a \$300,000 Challenge Grant from the National Endowment for the Humanities and many generous foundations and individuals. In fact, it was under the tent

at our annual Summer Party, hosted by Board Chairman Lisa Fox Martin at her home on the banks of the Hudson River in Catskill, NY, that the community came together to get us over the finish line. The event raised a record-breaking \$225,000! Thank you to all of the Summer Party sponsors. We are in awe of the amazing community behind this historic place.

This year we launched a new event in New York City bringing together leading American art scholars of today and emerging American art scholars of tomorrow. The first annual Scholars' Dinner was held at The Century Association and all proceeds from the event underwrote our annual Cole Fellowship Program. The event featured three scholars in particular who delivered


inspiring remarks: John
Wilmerding, Christopher B.
Sarofim Professor of American
Art Emeritus, Princeton
University, shared his personal
stories as a pioneer in the
field of American art; Mark
Mitchell, Holcombe T. Green
Curator of American Paintings
& Sculpture, Yale University
Art Gallery, revealed his lifechanging encounter with the
original art object; and Lauren

Palmor, Assistant Curator of American Art, Fine Arts Museums of San Francisco, brought her perspective on the American Story as a first generation American. In addition, our 2019 Cole Fellows presented their research and showed us that the future of American art is bright. Thank you to everyone who joined us and supported the special evening.

We came together for the annual Holiday Gathering and it was a lovely way to wrap up the year by getting together with friends in Thomas Cole's New Studio and around the dinner table. The proceeds from this year's event underwrote our growing school programs, providing students with free arts programming both inside their classrooms and at the historic site.


